- i) The Number of posts may increase or decrease as per the requirement.

- iv) Desirable Qualification of the candidate is to have at least 01 year of research/technical experience in the relevant field and experience in data handling, report writing, field work, etc., and familiarity with computer applications such as MS Office and other allied data analysis software.
- v) Recruitment shall be made through **WALK-IN-INTERVIEW**; however, relevant documents/ mark-sheet, including experience certificate, would be verified, and screening would be made. Candidates would be selected on the basis of the APCB Norms prescribed for the posts applied for.
